The meeting was called to order at 12:00 PM. Present were Chairman Sidney Baines, Commissioner Frank Kotowski, and Commissioner Roger Bergeron, Superintendent Bruce Kudrick and Bethany Hague.

APPROVE & SIGN MINUTES FROM FEBRUARY 25, 2013 COMMISSION MEETING

Commissioner Bergeron made a motion to accept the February 25, 2013 minutes as read. Commissioner Kotowski seconded. All in favor, motion carried unanimously.

READ CORRESPONDENCE

FINANCIAL REPORT – There was no financial report.

SUPERINTENDENT’S REPORT

PRESSURE WASHER – Supt. Kudrick received quotes from other companies for a new power washer, and the quote from Power Clean/HOP is still the better deal as the company will take the old reel in trade for a new one.

FLOWS FOR JANUARY AND FEBRUARY – The flows have risen somewhat but are still much lower than previous years.

CHANGE OF USE MEETING – Supt. Kudrick attended the Change of Use Meeting at Town Hall and was informed that the former Colonial Hardware will be the new home of Bond Auto Parts. The other item of note was that the building located at the corner of Memorial Drive and Hooksett Road will be demolished soon.

IFAS PROBLEMS – The air sparges are still continuing to block at least once a week, and no cause has been found yet. The letter to Kruger has been sent regarding the problem.

SCHEDULED APPOINTMENTS

There were no scheduled appointments.

The Commission did not go into non-public session.

OLD BUSINESS

VILLAGE WATER AGREEMENT – The Board discussed the final communication and check received from Village Water. The future needs regarding deduct meters and what the sewer department should do regarding them was also discussed. It was decided that a letter regarding the

Sewer Commission's position on the matter, including its ordinances and limits, will be sent to the Village Water Precinct to ensure all parties are informed. Commissioner Bergeron made a motion to accept the \$36,000 from Village Water Precinct to reimburse the Commission for overcharging the Sewer Commission on its water bills, Commissioner Kotowski seconded. All in favor, motion carried unanimously.
