Superintendent's Report

TIF (Tax Increment Financing) Bruce discussed some of the five options and tax payer concerns with connecting Exit 10 to the sewer lines. There is a TIF meeting September 19, 2017 taking place at the Town Hall at 6:00pm, anyone interested can attend.

City of Hooksett has completed crack filling (for roads etc) the plant and two of its pump stations need cracks filled so Bruce contacted Advanced Excavating, whom does liquid asphalt and they will fill the cracks. It was estimated to be \$800 for the cracks at the plant and \$427 each for the two pump stations. The Commissioners were satisfied with this estimate.

NH Solar Garden is coming out September 21, 2017 to discuss where the plant can put solar panels and what options would best fill the needs for the plant.

A review of the Mural for the side of storage unit at the plant is on September 27th, 2017.

Bruce went over his Budget for the Treatment plant; there was no increase in the budget from last year. Bruce was given the go ahead from the Commissioners to submit the Treatment plant budget.
