Approve and Sign Manifests

Approve and sign minutes from April 16:

Commissioner Frank Kotowski made motion to accept the April 16th minutes as read. Chairman Sidney Baines seconded. The motion was carried unanimously.

Superintendent's Report:

DMR: No violations for April

The plant did a split ecoli test with the state. The state and the plant had the same results. The plant has also had no violations since the first of the year.

Bridge: Bruce did an inspection on the two drop inverts (in the manholes) both are working and the Grand opening of the bridge is expected to happen in June.

The Knights of Columbus building was connected to sewer over the weekend.

Roof: There is a leaky roof down at the plant over the motor control center and it is leaking onto the blower. A 25 X 45 section needs to be replaced. Bruce had Skyline come out and give an estimate to fix it and it will be about \$14,970.00.

SNHU: The new dorm at SNHU is on hold. Bruce would like Don Graves to look into the acid neutralization systems that SNHU is putting in to see if this will have any effects on the sewer.

Bruce scheduled another carpenter to come out and look at the railings coming into the commission office, the wooden rails are rotting and falling off. Bruce is interested in finding out how much it would cost to have metal hand rails put in. The carpenter that was hired to fix the windows at the commissioner's office will be here next week to do so.

Old Business: TBuck will be back at the plant next week to continue with the upgrades to the plant

New Business: Commissioner Frank Kotowski made motion to move forward with Santec in placing borings under the river to continue with progress in connecting 3A to sewer. Chairman Baines seconded. The motion was carried unanimously.

Frank Kotowski made motion to move forward in working with Hoyle, Tanner in setting up the Asset Management program at the plant. Chairman Sidney Baines seconded. Motion was carried unanimously.
