**Dubois and King:** Nicholas is at the very beginning phase of gathering information to see what alternative there may be for Bow connecting to Hooksett Sewer. He is trying to gather information to put dollar amounts to these alternatives. The Sewer Commission needs to know what kind of gallonage would be needed and if there would be any upgrades required on the existing pump station. Nicholas is going to work on a feasibility report and will get back to the Commissioners before proceeding any further.

**Keach Nordstrom:** Matt Peterson had previously presented plans for Granite Heights to the sewer commission. He returned with John to clarify the project. Phase 1 will consist of 48 units (44 of which were previously paid for). Phase 2 will consist of 52 units. It was recommended to Matt and John to pay for the four remaining units for Phase 1. The remaining 52 units that are part of Phase 2 will need to be paid for in their entirety before any sewer work starts.

## **Superintendents Report:**

Dryer: The state fire inspector came to the plant on February 7, 2020 to look at the dryer.

**Autumn Frost:** This development is currently owned by a bank. Bruce was inquiring for a person interested in purchasing if the sewer commission was going to grandfather this development under the old system development fee rate. The sewer commission said they would not grandfather this development and whomever purchases it will have to pay the new rates.

**Underwood:** A representative from Underwood will be here February 24<sup>th</sup> to do the cold water test and data collection. Bruce and John will also be going to Claremont on Thursday with David Mercier from Underwood to look at different pump station designs.
