Approve Minutes from January 19, 2021: Commissioner Richard Bairam made motion to approve the meeting minutes from January 19, 2021. Commissioner Frank Kotowski seconded. All in favor, the motion was carried unanimously.

Read Correspondence

Financial Report: Guy connected with the sewer commission via zoom to give a brief overview on the Hooksett Sewer Commissions accounts.

- Commissioner Frank Kotowski made motion to transfer \$266,163.16 from the Hooksett Sewer Commission Trust-Plant & Composting account to the Hooksett Sewer Commission checking account for the Main Street Pump Station Assessment. Commissioner Richard Bairam secoded.
 All in favor, the motion was carried unanimously.
- Commissioner Frank Kotowski made motion to transfer \$21,285.50 from the Hooksett Sewer Commission Trust-Plant and Composting account to the Hooksett Sewer Commission checking account for the plant pellet dryer. Commissioner Richard Biaram seconded. All in favor, the motion was carried unanimously.
- Commissioner Frank Kotowski made motion to transfer \$3900.00 from the Hooksett Sewer
 Commission checking account to the Hooksett Sewer Commission-Trust property enhancements
 accounts for the second quarter fiscal year 2021 rent collected. Commissioner Richard Bairam
 seconded. All in favor, the motion was carried unanimously.
- Commissioner Frank Kotowski made motion to transfer \$42,000.00 in system development fees
 collected from the Hooksett Sewer Commission checking account to the Hooksett Sewer
 Commission Trust- Plant and Composting account for Wastewater Treatment Facility Phase 3A
 Capital improvements. Commissioner Richard Bairam seconded. All in favor, the motion was
 carried unanimously.
- Commissioner Frank Kotowski made motion to modify sewer rates from analysis for fiscal year 2022 (usage from July 1, 2021 through June 30, 2022) using as basis CPI-Urban for twelve months ended as of December 2020. The usage rate would go from \$6.35 to \$6.45.
 Commissioner Richard Bairam seconded. All in favor, the motion was carried unanimously.

 Commissioner Frank Kotowski made motion to write off impaired Composting Plant Expansion asset balance of \$267,118.44 with no effect on cash or budget, i.e. depreciation expense.
 Commissioner Richard Bairam seconded. All in favor, the motion was carried unanimously.
