Superintendent Conaty's Report:

Plant:

- The heater controls died in the bisulfate room, we are currently waiting on a new one
- The Enthalpy lab is closing. Superintendent Conaty is trying to locate a new lab for Bioassay test (CT & VT).
- Officially on EPA sanitary sewer overflow web reporting
- Re-enrolled in Biobot program at no cost

TIF Project:

- TIF expansion passed 6-2 by the Town Council

Phase 3A Plant Upgrade:

- New clarifier walkway design is being done

Solar:

- New solar tracking training is being held on Thursday
- Superintendent Conaty presented the Sewer Commission with information on 2021 solar totals for the Hooksett Wastewater Treatment Facility and he went over the solar farm payback information sheets.
- The mower that the Sewer Commission purchased to mow the solar farms will be delivered in May.

Force Main Replacement:

- Still waiting on design from Holden Survey
- Martin's Ferry warrant article passed 6-2 at the Town Council meeting and 10-0 at the Budget Committee meeting.
- Superintendent Conaty has been in contact with Ron from MS & G, he is looking forward to the project.

Dewatering Upgrade/Pilot Study:

- Recalculating numbers for proper press size. Meeting with Underwood on calculations hopefully this week.
- Superintendent Conaty presented a video to the Sewer Commission on the Dewatering process.

Asset Management:

- Continuing to work on work orders and GIS. John Jackman will be in tomorrow.

Merrimack Street Station:

- Talking to Underwood on design.

Other:

- Warrant Articles-deliberative session I son Saturday February 5th @ 9am.
- Superintendent Conaty is working on annual CMOM report that is to be filed in March.
- 1823 Hooksett Road information was reviewed. Superintendent Conaty will meet with Pichette to get a rough estimate.

Old Business: TIF updates every third Tuesday of the month


New Business: Next Sewer commission meeting is scheduled for February 15, 2022.
