This meeting was called to order at 12:00pm. Present were Chairman Sidney Baines, Commissioner Richard Bairam, Superintendent Ken Conaty, Assistant Superintendent John Clark and Bruce Kudrick. Commissioner Robert Duhaime was excused from this meeting.

Approve and sign manifest

Approve Minutes: Commissioner Richard Bairam made motion to approve the meeting minutes and workshop minutes from June 7, 2022. Chairman Sidney Baines seconded. All in favor, the motion was carried unanimously.

Read Correspondence

Financial Report: Guy Beloin came in to give a brief overview of the Sewer Commission accounts.

- Commissioner Richard Bairam made motion to transfer \$3900.00 from the HSC checking account to the HSC Trustees-property enhancement account for the last three months rent collected from Old Castle for the fiscal year 2022 for the fourth quarter from April to June 2022. Chairman Sidney Baines seconded. All in favor, the motion was carried unanimously.
- Commissioner Richard Bairam made motion to transfer \$30,000.00 from the HSC checking account to the HSC Trust-plant and composting account for three months ended June 30, 2022 of fiscal year 2022. Savings usage from renewable energy system. Chairman Sidney Baines seconded. All in favor, the motion was carried unanimously.

Scheduled Appointments: 12:00pm Doug McGuire from the Dubay Group RE: Car Wash/Dog Wash

• Doug presented the plans for the car wash/dog wash located at 1554 Hooksett Road. Superintendent Conaty had already previously viewed the plan and submitted his request for changes which have been completed. The car wash will be a four bay facility, with a single bathroom for employees to use. They are estimating to use 5500 gallons a day. There are multiple entrances but one exit to the facility which will come out on memorial drive. Chairman Sidney Baines did express concern on the exit being blocked during school dismissal. The parent pick up line of cars does stretch all the way down memorial to the light on most days. Doug did say they are having a traffic study done. This project was approved by the Hooksett Sewer Commission.

12:15pm Bruce Kudrick RE: Treatment Plant History

Bruce Kudrick is volunteering his time to research the history of the Hooksett wastewater
treatment facility. He presented some of the information he has gathered to the Sewer
Commission. Bruce has information from as far back as 1962. The sewer commission took some
time to look over Bruce's notes and to discuss their memories. Bruce told everyone that if there
was something they wanted added in his report to just let him know.

Superintendent Conaty's Report:

Plant:

- Plant is still running excellent discharge numbers with no violations.
- DMR QA (quality assurance) study is complete, just waiting on the results
- RSA pump down at the plant is back in service
- There was an issue with the PLC for the belt press that was repaired
- Sodium Hypo- went from \$.09 to \$.21/pound for the next year

TIF Project:

- Underwood completed the design yesterday and it was submitted to NHDES
- Superintendent Conaty is assisting with the TRI-town easement design, which has been completed and sent for review to the HSC attorney (attachment 1).

Phase 3A Plant Upgrades:

- PBR is sending submittals to Underwood
- The head-works down at the plant has been torn out. Superintendent Conaty is looking into a stainless grit hopper
- · Concrete deliveries are at least two weeks out
- A temporary system is in place for the screens
- Bypass pumping is being done this week
- Next construction meeting is scheduled for July 5, 2022 at 1:00pm.
- A list of up charges or increases were submitted
 - 1. Roof Drains
 - 2. Basement sump pump/rear bathroom drain
 - 3. Veolia- still waiting on response from them
 - 4. Air diffusers- in research with Underwood to find a cheaper alternative

Solar:

Continues to be on track

Dewatering Upgrade/Pilot Study:

- Loan application is in process. One to ARPA and one to SRF.
- Superintendent Conaty, Chairman Sidney Baines and Guy Beloin will be attending the town council meeting tomorrow to move forward with financing.

Asset Management:

- Work orders are progressing
- Working on risk management

John Jackman and Eliza Morrison (NHDES) are coming to update the sewer commission on July
 5, 2022 at 11:30am.

Other:

- A fire extinguisher inspection was done at the plant and the Sewer commission office. The fire extinguishers need to be replaced every six years, this was completed.
- Boot allowance- The Sewer Commission discussed raising the boot allowance from \$125 to \$200
- Superintendent Conaty showed the sewer commission the electricians install equipment cost sheet that he was given for the work to be done on the radio communications (attachment 2).
- 1554 Hooksett Road-car wash/dog wash project is waiting for NHDES. This project is projected to use 5500gpd.
- The pre-construction meeting for Legends Drive Marmon Aerospace project is next week. Superintendent Conaty is waiting on Fees to be paid.
- The 5450 GPD Eversource building is waiting on fees to be paid and a pre-construction meeting to be scheduled.
- There are several projects that Superintendent Conaty is waiting on overdue documentation on.
 No certificates of occupancy will be issued until all paperwork is filed with the Hooksett Sewer Commission.
- Superintendent Conaty is working with Eversource on new discharge and filling out the IDP permit application.
- Superintendent Conaty attended a water council meeting. It was an all day hearing on AOT permits.
- Superintendent Conaty worked with NEWEA on new collection system licenses.
- Superintendent Conaty and Assistant Superintendent John Clark attended the touch a truck day at the Hooksett library. They brought the loader and crane truck.
- Superintendent Conaty attended the joint loss committee meeting
- There was an intern from NHDES at the wastewater treatment plant last week that shadowed Scott in the lab.
- Superintendent Conaty is attending the NHWPCA summer meeting on Friday June 24th.
- There will be a climate vulnerability meeting in August.
- Superintendent Conaty will be attending an education committee meeting July 28th.
- Superintendent Conaty presented information to the Sewer Commission on possibly upgrading
 the grit classifier down at the plant (attachment 3). The cost would be \$92,667.00.
 Commissioner Richard Bairam made motion to approve the purchase of the new grit classifier
 for the Hooksett Wastewater Treatment facility. Chairman Sidney Baines seconded. All in favor,
 the motion was carried unanimously.

Old Business: TIF updates are every third Tuesday of the month. Chairman Sidney Baines expressed his disappointment with the fact that no one from the town showed up for this meeting.

New Business:

- Next Meeting is Tuesday July 5, 2022
- Safety Manual update
 Commissioner Richard Bairam made motion to accept recommended updates to the Safety
 Manual as approved by the Town Council on June 23, 2021. Chairman Sidney Baines seconded.
 All in favor, the motion was carried unanimously.
 - Underwood is having their 40th Celebration on Thursday June 23rd

Non-Public Session: Commissioner Richard Bairam made motion to go into non-public session at 1:40pm, under RSA 91-A:3, II(a). Chairman Sidney Baines seconded. All in favor, the motion was carried unanimously. Commissioner Richard Bairam made motion to come out of non-public session at 2:00pm. Chairman Sidney Baines seconded. All in favor, the motion was carried unanimously. The Commissioners discussed wages and COLA increase. Superintendent Conaty's raise will be merit only.





MODEL L - 20° GRIT CLASSIFIER

For the one (1) Model $L - 20^{\circ}$ Grit Classifier, we propose to furnish the following:

- 1 <u>Drive unit</u> consisting of a shaft mounted cycloidal-helical gear reducer powered by a ¾ hp, 3 phase, 60 Hertz, 460 volt, ball bearing, continuous duty, constant speed, totally enclosed, explosion proof, fan cooled motor with leads to a large conduit box.
- 1 <u>Screw convevor</u> consisting of a 9-inch diameter stainless steel helical screw with ¼-inch thick flights and a ½-inch wide hardened weld on the leading face of the flight.
- 1 <u>Trough</u> fabricated with ¼-inch stainless steel plate, with 6-inch inlet and outlet connections, 2-inch drain connection, external mounted lower bearing, and an adjustable overflow weir. A support frame sets the screw conveyor at a 20° angle.
- 1 <u>Spray wash system</u> with ¾-inch diameter brass body slow-closing solenoid valve for flow control, ¾-inch diameter ball valve for volume control and a water filter.
- 1 Set of anchor bolts stainless steel.

Approximate shipping weight of the grit classifier is 2,900 lbs.

EXCLUSIONS: The following are not included in this offering:

ERECTION DATA: The grit classifier will be shipped as a unit for installation at the plant site. We estimate a total of 24 man-hours for installation of each unit.

SHOP PAINTING: All ferrous metal parts above and below the water level will be grit blasted and receive a shop coat of Tnemec #69 or #161 Primer or Tnemec Series 1 Omnithane Primer. Aluminum, stainless steel and galvanized steel parts will not be shop painted. Motors and reducers will receive a shop coat of machinery enamel. Field paint and painting by others.

SHOP DRAWINGS: We will furnish one (1) electronic copy of drawings for the equipment without charge. The reviewed drawings are to be returned to us with the notations or approval stamp of the Engineer. Drawings will require 6 - 8 weeks after receipt of an order and complete information, including plans and specifications, field dimensions or verification of field dimensions, which are to be provided at no cost to Lakeside.

SHIPMENT: Shipment can be made in 20 - 26 weeks after receipt of approved drawings by our home office. Foundation materials can be shipped within twenty (20) days after drawings are approved.

EXISTING STRUCTURE NOTE: The Contractor shall be solely responsible for measuring and providing Lakeside with accurate, as-built dimensions for all existing structures where Lakeside is furnishing equipment. This information must be made available to Lakeside in a timely manner to avoid delaying the equipment delivery schedules outlined in this proposal. In the event that dimensions are not provided or the provided dimensions are in error, which result in modifications to either the equipment or the adjacent structures, the Contractor shall be solely responsible for all labor, materials and costs to correct the associated issues.

<u>INSTRUCTION BOOKS</u>: One (1) electronic copy of the installation, operation, lubrication and maintenance book will be furnished before shipment of the equipment.

SERVICE: Inspection of the installed equipment can be made following notice by you that you are ready for such service. The cost of two (2) days of service in one (1) trip is included in our proposal price. Additional service is available at the rate of \$1,350/day plus living and travel expenses.

PROPOSAL PRICE: Includes service as stated above and is F.O.B. our shop with freight allowed to job site.

PRICE FIRM: For thirty (30) days from bid date. Due to the existing environment of the price increases in steel and the volatility of those prices that exist today, the price shown above is based on the present day cost of materials.
