

Hooksett Sewer Commission Meeting Minutes September 5, 2023



This meeting was called to order at 12:00pm. Present were Chairman Sidney Baines; Commissioner Richard Bairam, Commissioner Robert Duhaime, Superintendent Ken Conaty and Assistant Superintendent John Clark.

### Approve and Sign manifest

**Approve meeting Minutes:** Commissioner Richard Bairam made motion to approve the regular meeting minutes and the workshop minutes from August 15, 2023. Commissioner Robert Duhaime seconded. All in favor, the motion was carried unanimously.

# **Read Correspondence**

Financial Report: Guy came in and gave a brief overview of the HSC accounts to the Sewer Commission.

- Commissioner Richard Bairam made motion to transfer \$37,200.00 system development fees
  collected from Hooksett Sewer Commission checking account to Hooksett Sewer Commission
  trust-plant and composting account. Commissioner Robert Duhaime seconded. All in favor, the
  motion was carried unanimously.
- Commissioner Richard Bairam made motion to transfer \$95,402.42 from the HSC Trustee- plant
  and composting account to the HSC checking account for WWTF Phase 3A Capital Improvements
  project including PRB payment request #16 and Underwood Engineers for \$316,573.54 through
  June 30, 2023 and \$29,391.78 for construction interest on SRF note payable for same project
  less PRB retainage amount transfer correction \$250,562.90. Commissioner Robert Duhaime
  seconded. All in favor, the motion was carried unanimously.
- Commissioner Richard Bairam made motion to transfer \$7,737.61 from Hooksett Sewer
  Commission trustee- plant and composting account to Hooksett Sewer Commission checking
  account for Martins Ferry Pump Station including Underwood Engineers up through June 30,
  2023. Commissioner Robert Duhaime seconded. All in favor, the motion was carried
  unanimously.
- Commissioner Richard Bairam made motion to transfer \$4,104.00 from the Hooksett Sewer Checking account to Hooksett Sewer Commission Trust- Plant and composting account for first quarter of calendar year 2023 from Knollwood Energy. Commissioner Robert Duhaime seconded. All in favor, the motion was carried unanimously.

Scheduled Appointments: 12:00pm- Matt Murray-Auditor RE: Informational about Hooksett Sewer Commission Audit. Matt went over the process of the type of Audit that is done at the Hooksett Sewer Commission. Matt stated that he is very appreciative of the type of records that Guy Beloin keeps for the sewer commission. Chairman Sidney Baines asked Matt if there was anything that could be done to

help the process further. Matt went over a few ideas with Guy and the Sewer Commission. The Sewer Commission thanked Matt for his time and the information he supplied to them.

### **Superintendent Conaty's Report:**

#### Plant:

- Plant numbers continue to be stable
- Clarifier 2 was cleaned and inspected, the wipers are being replaced now
- Nitrate recycle pump is running and ammonia levels are down

#### Solar:

• Solar production looks good. Assistant Superintendent John Clark went over solar production with the sewer commission (see attachment 1).

#### Phase 3A Plant upgrades:

- Punch list is 99% complete
- Final walkthrough completed, remaining punch list items moved to warranty list (formality of the state)
- Final up charge balance sheet is being worked on

# Force main replacement/Martins Ferry pump station upgrades:

Working on design, waiting on Underwood for easement, documents are 30% complete

### **Dewatering Project:**

- Met with Underwood- 90%, plans are almost complete
- Bids for screw press due at 2:00 today
- Superintendent Conaty opened the bids for the screw press project this was just for the screw press equipment and other ancillary items.
- There was one bid from BDP in the amount of \$927,500.00 for two full units. The Bids is valid for 60 days from September 5, 2023.
- Commissioner Robert Duhaime made motion to accept BDP's bid proposal #082923-1503 in the amount of \$927,500.00. Commissioner Richard Bairam seconded. All in favor, the motion was carried unanimously.

## TIF Projects:

- Tri Town under construction. Excavation on PS is started. Bore test done, showed all sand, three larger 36" wells installed on 08/24/2023
- Price from PARK is coming soon for extending sewer to the end of the cul-de-sac on meadowcrest.

#### Other:

- Investigating inflow issue around Martins Ferry pump station, the pump station overflowed on 07/16/2023 a flow assessment is coming in ASAP, need to check Martins Ferry basin, working with flow assessment and got flow assessment maps to look at.
- · Ardon drive area is going well, will clean in September time frame
- 1461 Hooksett Road, Ridgeback storage in under construction
- 108 Mammoth Road, Mastiano, ongoing construction, passed primary construction tests.
- 7 Martins Ferry Road, Lamontagne, ongoing construction
- Marmon is working on completion
- Black Diamond car wash is completed they are waiting on CO.
- The HSC sign project is complete will be set on September 21, 2023. Sign dedication will be done around 2:00pm.
- Superintendent Conaty is planning on rewriting construction standards this winter
- All HSC small trucks are inspected
- All HSC large trucks went to Platinum truck for service and inspection
- Superintendent Conaty would like to buy a document scanner for \$1000.00 to start cutting
  down on paperwork being kept. -Commissioner Richard Bairam made a motion to allow
  Superintendent Conaty to purchase the document scanner for \$1000.00. Commissioner Robert
  Duhaime seconded. All in favor, the motion was carried unanimously.
- A walk through was done with PRB at the Golden Gate and Merrimack St pump stations.
- Superintendent Conaty went over the tentative budget for 2024-2025 with the Sewer Commission.
