This meeting was called to order at 12:00pm. Present were Chairman Sidney Baines, Commissioner Richard Bairam, Superintendent Ken Conaty and Assistant Superintendent John Clark. Commissioner Robert Duhaime was in attendance at 12:15pm.

Approve and Sign manifest

Approve meeting minutes: Commissioner Richard Bairam made motion to approve the workshop and regular meeting minutes from April 16, 2024. Chairman Sidney Baines seconded. All in favor, the motion was carried unanimously.

Read Correspondence

Financial Report: Guy came in to give the Sewer Commission a quick overview of the Hooksett Sewer Commission accounts.

- Commissioner Richard Bairam made motion to transfer \$36,778.71 from the HSC trust plant and composting account to the HSC checking account for the WWTF Phase 3A capital improvements trust cash expenditures through April 2024. Chairman Sidney Baines seconded. All in favor, the motion was carried unanimously.
- Commissioner Richard Bairam made motion to transfer \$17,704.79 from the HSC trust plant and composting account to the HSC checking account for Martin's Ferry pump station expenditures through April 2024. Chairman Sidney Baines seconded. All in favor, the motion was carried unanimously.
- Commissioner Richard Bairam made motion to transfer \$104,028.30 from the HSC trust plant and composting account to the HSC checking account for Meadowcrest Road sewer expenditures through April 2024. Chairman Sidney Baines seconded. All in favor, the motion was carried unanimously.
- Solar panels will be paid off in 2027, which is much earlier than originally expected

Force Main Replacement/Martin's Ferry pump station upgrade:

- Seven easement are needed. Superintendent Conaty has contacted all easement sources
- Superintendent Conaty will be attending the next Town Council meeting to discuss the easements needed from the town.

Dewatering Project:

- Screw presses are to be delivered at the end of December
- The sludge containers have been delivered

Under the General Services Agreement for Professional Services as Consulting Engineer for the Owner (Contract dated March 2, 2015) Engineer is authorized to proceed with the following work:

Background

The Hooksett Sewer Commission has three (3) aged positive displacement blowers serving their two (2) aerated sludge holding tanks which have reached the end of their useful life. The existing blowers are oversized for their current application and the HSC wishes to demo all three (3) of the existing blowers and replace them with two (2) new blowers utilizing regenerative blower technology. All of the air piping in the existing blower room will be demolished with the exception of two (2) intake lines that pass through the ceiling to the roof and the common discharge leaving through the floor. The HSC intends to fund this project with local reserve monies. The following scope of engineering services is to provide design phase services for this work.

Scope of Services

Task 1 - Sludge Aeration Blower Design

- Conduct a site visit to the treatment plant to review the existing conditions in the sludge blower room and take critical dimensions to develop a reasonable record drawing for the room for use in developing demolition and modification figures.
- Prepare a design calculation for the required aeration rate and design pressure for the new blowers as required to serve two (2) existing sludge holding tanks. Underwood will utilize existing equipment information and record drawings to prepare the calculation.
- Request a proposal for two (2) new regenerative blowers with accessory components from FPZ Corporation.
- Develop process and electrical demolition and modification figures utilizing the sludge aeration blower record drawings and PDF editing software.



- Prepare blower and SS piping technical specifications.
- Prepare a letter form request for proposal document for the Town to solicit pricing from contractors to perform the work.
- Submit the draft RFP document to the HSC for review. Respond to review comments received from the HSC and finalize the documents.
- Provide an electronic copy of the final RFP document to the HSC for requesting contractor pricing.

Owners Responsibility

- Provide record drawings for the existing sludge blower room, air yard piping, and sludge blower electrical
- Provide O&M information for the existing sludge blowers

Work Not Included

• Permitting and funding assistance services.

Engineering Fees


Budgets

Fees for engineering services will be on an hourly basis for the personnel involved. Such hourly fees will be based on the Engineer's technical payroll plus an allowance to cover overhead and profit. Fees also include reimbursement for transportation expenses (per mile), out-of-pocket travel expenses (tolls), prints, telephone calls and miscellaneous materials that may be required to complete the work.

Suggested budgets, as used herein, are best estimates by Underwood Engineers. The budgets are based on available information and prior to detailed research on the Project. Budgets are not intended to be fixed prices but are reasonable estimates of average costs to complete projects of similar size. Budget will not be exceeded without written authorization.

Schedule

Underwood will commence work on this project within five (5) days of contract execution and deliver the final packages to the HSC within 120 days thereafter.
